Gale House Loan Payoff – Nile

- Presented review of UTUUC Loans, Terms & Issues as of 2/12/2019
- 1019 South Blvd no change recommended
- Gale house recommend using operating funds to pay off loan. Want to do it before sale to Byline Bank.
- Motion to pay off loan of \$167,353 plus fees associated. Bill motioned to approve, Terry second (Unanimous)
- Karen asked about Alciun Elizabeth needs to look into it.

Review of 2018 Finances – Nile

- Pledges came in how we predicted
- Predicting cash in December is harder to predict because of changes in tax law.
- Stable from 2017 to 2018 and budget estimate was good
- Too much money in savings account and it's not earning interest
- Finance and investment committee being combined 2 years ago has been an advantage.
